Telangana Resource Centre having a wide range of intellectuals and historians who have some specific stream of thoughts for creation of a platform to share the views of individuals and take collective conscience on various aspects which will lay down guidelines for Telangana. On the same lines TRC submit to the GOM, the following points referred in top.

1. We Propose that the Telangana state should be formed with ten districts i.e, Mahabubnagar, Medak, Nizamabad, Adilabad, Karimnager, Rangareddy, Hyderabad, Nalgonda, Khammam and Warangal with 119 MLA's and 17 MP's constituencies intact without any deviations.
2. Reorganization of state act has no provision for deciding the state of the capital. Let the new state has its own choice in deciding its own capital. We are rejecting the proposal of common or joint capital. Union government's insistence on proposing state capitals would prejudice the spirit of federalism.
3. The declaration of capital city by the residuary Andhra Pradesh government should be made simultaneous with the formation of residuary state.
4. We were always treated with discrimination. At least now onwards the declared and identified backward districts in Telangana should be given proper financial packages by the centre.
5. Law and order is a state subject. Therefore the respective state has to control the law and order and on the issue of internal securities within the state, as there arises a need the state would seek the assistance of the centre.
6. We propose that all the existing agreements and allocations of natural resources be subjected to renegotiations.

The decision to accord national status to Polavaram be withdrawn forthwith, for it not only infringes on the rights of the Telengana but portends a disastrous consequences to human habitations particularly Adiwasi lands that are under 5th schedule areas and also endangers environmental stability around.

7. Coal and gas allocations for power generation should be accorded to new state of Telengana as a priority. The centre should provide a package of 70,000 crores towards a 5000 MV power transmission for Telengana.

8. The assets, public corporations and the lands of Telengana during the merger into Andhra be exempted from distribution between two states as they belong to Telengana only.

Liabilities are shared between two states on the basis of proportionate consumption of two regions.

9. Till the application of GO 610 and subsequent rulings for allocation of employees the commission should not be constituted and call for option by the employees. Before reallocation of employees, all the arising vacancies should be filled by respective states.

10. Article 371 D should be reviewed in the light of observation made in point 9

11. A) We propose that state archives be continued with Telengana as it has been its storehouse of culture and history. Any document that pertains to the regions of residuary state be copied and made available to that state according to the established norms.

B) We propose an allocation of 200,000 crores be sanctioned to Telengana state by the centre towards restoration of Hyderabad and its surrounding areas as they were subjected to environmental, topographical and cultural ecological destruction for all these years. Rivers, lakes and municipal systems were destroyed and require urgent attention of restoration.
